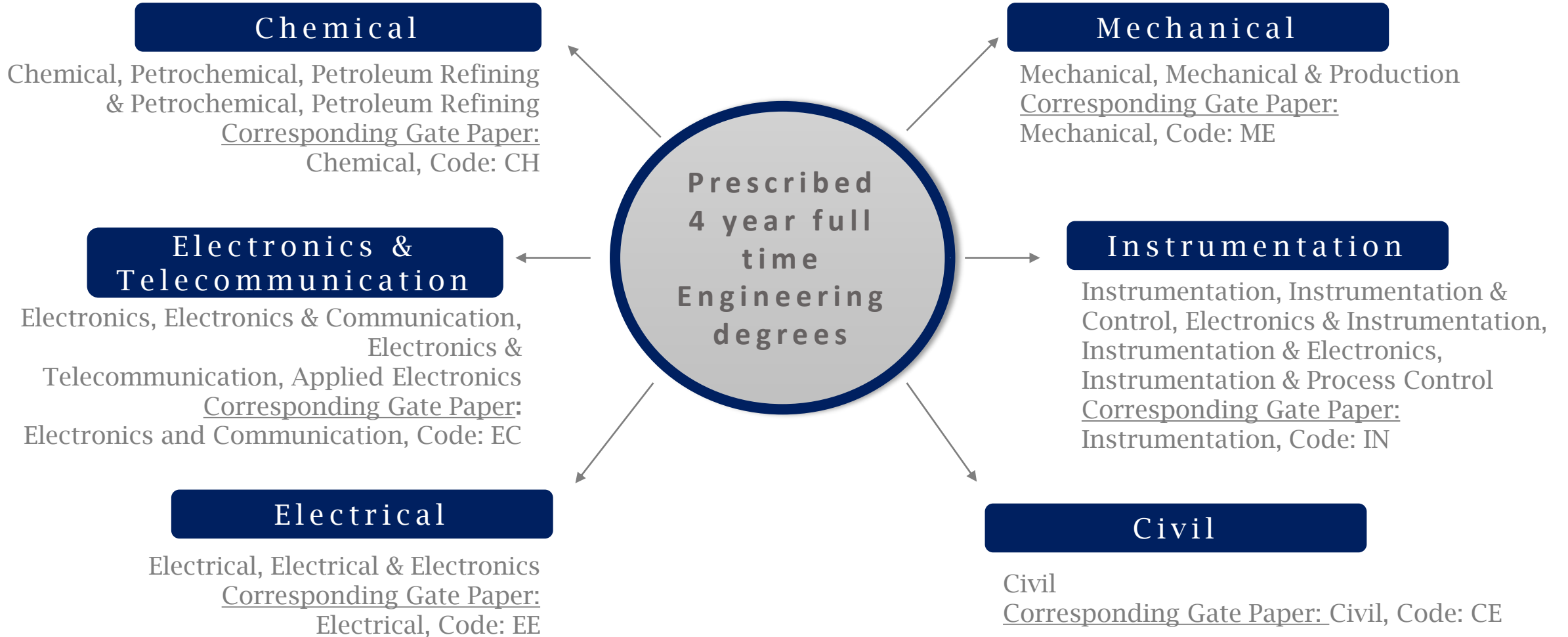

# Eligibility: Education Qualifications



Note: Candidates having any other degree/combination degree eg. Production Engg., Automobile Engg., Mechatronics, Industrial Engg., Construction Engg. etc., other than mentioned above are not eligible to apply. These exclusions are only indicative and not exhaustive

Candidates currently in final year of their engineering studies may also apply. However, if selected, they must submit their final mark sheet by 31<sup>st</sup> August 2018. At the time of applying, the aggregate marks required will be same as mentioned above as per respective category

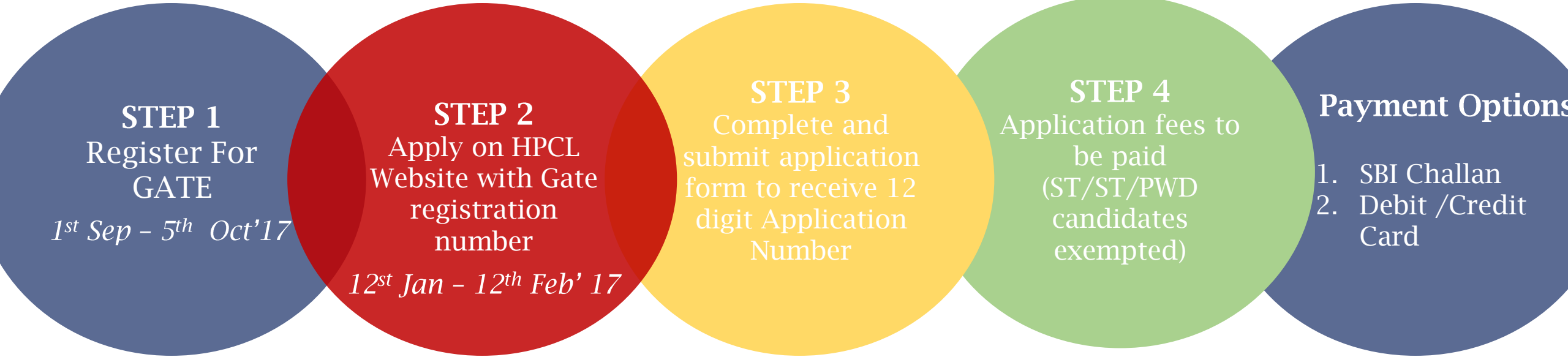


# Shortlisting and Placement

- Candidates appearing in a GATE paper which is different from their Qualifying Engineering discipline will not be considered for further selection procedure.
- The Gate marks for the year **2018** only will be considered for this recruitment process
- A candidate can apply against **one** discipline only. Candidates applying for more than one discipline will not be allowed to sit for both roles
- On the basis of valid GATE 2018 marks, qualified candidates will be called for further selection process in a predetermined ratio in order of the category-wise discipline- wise merit list.
- Selection process would include: Group Task/Group Discussion and/or Personal Interview. In addition to the above, any other selection tools/tests may be administered, at the sole discretion of the management. Candidates will have to qualify through each stage of selection process successfully for selection
- Merit List of successful candidates will be drawn basis 85% weightage to GATE 2018 marks and 15% to Group Discussion/Task and/or Personal Interview
- Selected candidates shall have **all-India transfer liability**. Posting/ Assignment can be in any SBU/Division/Department of the Corporation at any place in the country/otherwise.
- These positions generally involve working in shift duties. Selected candidates may also be posted in any of the subsidiaries/Joint Ventures or any department of Government of India.

# Payment of Application Fee

Applicants are required to pay a Non-Refundable Amount as Application fee.  
*SC, ST & PWD candidates are exempted from payment of application fee.*

## State Bank of India Challan

### Step 1

After two working days from online application take a **print of 2 part challan** (1.Candidate copy, 2.Bank copy) along with **filled application form** and deposit amount with pre-printed challan in **HPCL Powerjyoti A/C Number 32315049001** at any branch of SBI across country

### Step 2:

Ensure that bank affixes '**payment received**' stamp and **Journal no.** on two parts of challan. Collect the '**Candidate's copy**' of 2 part challan from bank and preserve the same for future reference.

### Step 3:

Check within 3-4 working days from date of payment of application and processing fee if the application payment status has changed to "**Payment Received**".

### Step 4:

In case payment status is not updated within 3-4 working days then kindly send the scanned copy of paid challan to [hpclgate@mail.hpcl.co.in](mailto:hpclgate@mail.hpcl.co.in)

## Online Payment through Debit/ Credit Card

### Step 1

Pay application & processing fee online by using Debit/ Credit card. The payment status will automatically change to "Payment Received", immediately on successful receipt of fees.

### Step 2:

Check on payment status of application is "Payment Received" is displaying.

### Step 3:

Take print of acknowledgment of payment and preserve the same for future reference

**NOTE:** Application fee once paid will not be refunded under any circumstances. Candidates are therefore requested to verify their eligibility before payment of application fees.



# Concessions and Relaxations

- Reservation of posts for **SC, ST** and **OBC-NC** are as per Government Directives.
- Vacancies will be reserved for **PWD** (Persons with disabilities -with degree of disability 40% or above) as per presidential directives
- Some of the posts of Officer Engineering Discipline are suitable for **Hearing Handicapped** category and certain categories of **Orthopaedic Handicapped**.
- Appointment in these vacancies will be offered to PWD candidates after considering the nature of duties & responsibilities of the job, location, hazard, strain & other factors, also considering that the disability is not likely to interfere with the performance of duties of the post with reasonable efficiency and without possible deterioration of his/her health.
- However, the final appointment would be based on candidate's medical fitness with respect to job profile of the identified posts.

Further to this, according to Notification No: 16-15/2010 DD.111 DT.29/07/2013 by Ministry of Social Justice & Empowerment, list of positions/disciplines in which PWD candidates are eligible to apply for this recruitment drive is given below.

# Concessions and Relaxations

- The reserved category candidates are required to produce the **original caste/ PWD certificate/s** in prescribed format of Government of India, issued by the competent authority at the time of interview, in support of their claim. The OBC-NC (OBC-Non Creamy layer) candidates will be required to submit a valid caste certificate in the prescribed format applicable for purpose of reservation in appointment to posts under Government of India/Central Government Public Sector Undertaking as contained in DOPT Memo No. 36036/2/2013- Estt. (Res.) dated 30-05-2014 from a competent authority issued in the year of advertisement. Further the OBC-NC candidates will have to give a self-undertaking, at the time of Personal Interviews if called for, indicating that they belong to OBC-Non Creamy Layer.
- The OBC candidates who belong to “**Creamy Layer**” are not entitled for concession admissible to **OBC-NC** candidates and such candidates will have to indicate their category as Unreserved (**UR**). The name of caste and community of the candidate must appear in the ‘Central list of Other Backward Classes’
- If the SC/ST/OBC-NC/PWD certificate has been issued in a language other than English/Hindi, the candidates will be required to submit a self-certified translated copy of the same either in English or Hindi.
- **Maximum age relaxation** is 5 years for SC & ST, 3 years for OBC-NC and 10 years for PWD (UR), 13 years for PWD (OBC-NC) and 15 years for PWD (SC/ST) candidates, as applicable.
- Maximum age relaxation is 5 years for candidates domiciled in Jammu & Kashmir between 01.01.1980 and 31.12.1989 relaxation by 5 years is applicable for Ex-servicemen & Commissioned Officers (including ECOs/ SSCOs) subject to rendering minimum 5 years’ service in Armed Forces and fulfilment of other conditions prescribed by Govt. of India.
- Relaxed standards in assessment/selection will be applicable for SC, ST, OBC-NC & PWD candidates.

- Candidate should keep scanned copy of passport size photo (same as affixed in GATE) (in jpg / gif format less than 50 kb) and resume (in doc/docx format less than 200kb) ready before filling online application form
- Fill in the online form with all the relevant details. Upload a scanned copy of your passport size photo (same as affixed in GATE) and resume along with the online application form. Candidates should ensure that the relevant details viz- Name, Date of Birth, Address, GATE 2018 Registration No etc. entered in HPCL Online application are the same as entered in the GATE 2018 application

You will get a system generated 12 Digit Application No. Please note that this Application No. is important and will be required for all future references throughout the selection process. Take a printout of the Online Application Form, and affix passport size photograph (same as affixed in GATE), sign at the space provided and keep it safely for future reference
- Choose the option for Payment of Application & Processing Fee
- Candidates are “NOT” required to submit hard copy of application forms to HPCL. The details once filled in the online application form will be considered final and no changes will be entertained w.r.t. personal/ any other details, later on



# General Instructions

- Only Indian Nationals are eligible to apply
