Selection will be made on the basis of a written test and interview. The other terms and conditions applicable for this recruitment are as follows:

A) Method of Submission of Application

Interested and qualified candidates may submit their application online through the "careers" link in our website www.malabarmilma.com upto 4 PM on 21-05-2015 (Indian Standard Time). Applications submitted by any other means including post, e-mail, courier, by hand etc. will not be accepted. **Applications will not be accepted after the above deadline.** There will be no application fee. Candidates who qualify in the written test will have to produce the original certificates (along with one photocopy attested by a Gazetted Officer) to prove academic qualification, marks obtained for post graduate degree exam in the case of Assistant Marketing Officer, date of birth, work experience and eligibility for reservation and relaxation in age limit at the time of interview. The certificates should be in English or Malayalam language. Certificates in other languages should accompanied by its certified English translation. Those who fail to produce the above documents at the time of interview will not be eligible for appointment or relevant reservation/age relaxation benefit as the case may be.

B) Educational Qualifications

All academic qualifications should be recognized by the concerned statutory authorities in India. Provisional degree or other certificates will not be accepted as proof of academic qualification and candidates who produce only provisional degree or other certificates will not be permitted to attend the interview. Technical qualifications other than MBA/MCA obtained through distance education will not be considered as prescribed qualifications.

C) Reservation

Ten percent of **total posts** are reserved for SC/ST candidates. They should produce the original certificates prescribed in the table in **section E** below (along with a copy attested by a gazetted officer) at the time of interview for availing reservation benefit. Fifty percent of **vacancies** are reserved for permanent serving employees of Anand Pattern Co-op. Milk Societies (APCOS) affiliated to MRCMPU Ltd., provided they have the prescribed qualifications notified above and have minimum regular service of 3 years in the society. They should produce the original certificates prescribed in the table in **section E** below (along with one copy attested by a gazetted officer) at the time of interview for availing reservation benefit. If sufficient number of qualified candidates are not available in the rank list from among APCOS employees, such vacancies will be filled up from the rank list in the order of rank.

D) Age Requirements

General category candidates must have completed 18 years of age and must not have completed 40 years of age as on 01-01-2015 (eligible date of birth from 02-01-1975 to 01-01-1997). Candidates should produce the original SSLC certificate or the original certificate issued by the Registrar of Births and Deaths (in English or Malayalam language) showing date of birth, (along with one photocopy attested by a gazetted officer) at the time of interview.

E) Age Relaxation

Relaxation in upper age limit will be given to the following categories if they produce the original documents shown below (along with one copy attested by a gazetted officer) at the time of interview. Those who do not produce the documents will not be eligible for the age relaxation benefit and will be considered as general category candidates.
