

Instructions

The 'Written Test' of the shortlisted candidates shall be conducted on 02.01.2018 at Spiritual Growth Centre, Katra (Opposite Shri Mata Vaishno Devi Shrine Board, Central Office, Katra)

The Candidates are required to bring their Photo Identity Proof for appearing in Written Test. The candidates without identity proof, shall not be allowed to appear in the Written Test

The Written Test shall be followed by a 'Personal Interview' of the shortlisted candidates on 04.01.2018 at Spiritual Growth Centre, Katra (Opposite Shri Mata Vaishno Devi Shrine Board, Central Office, Katra), the names of whom shall be displayed on the Shrine Board's website www.maavaishnodevi.org on 03.01.2018 by 01:00 PM. The candidates are required to bring original documents related to their qualification/ DOB (10th class Diploma and mark sheet)/ Experience for appearing in Personal Interview

Candidates must not communicate with another candidate or anyone else other than supervisory staff during an examination. If there is a need to raise a point of immediate urgency, the candidate is required to raise a hand to attract the Superintendent/ Invigilator's attention. The candidate may then explain the matter in a quiet and non-disruptive manner

Candidate is only required to carry on his/ her person blue/ black pens for use in the examination. No other gadget shall be allowed.

Candidates are not allowed to bring any electronic gadget such as Cell phones, Electronic diaries or any other electronic device with memory or Listening devices and recording or photographic devices, Electronic Wrist Watches, wrist watch phones, pagers, pen scanners or multimedia devices or any other communication devices even in switched OFF mode inside the examination hall. Shrine Board will not make any provision to keep them in safe custody and Candidates themselves are responsible for safety of their belongings.


Note:
