ADVERTISEMENT

Applications in prescribed format are invited from citizens of India for filling-up of 03 (three) posts of Veterinary Officer Group "A" (Gazetted) under the Department of Animal Husbandry and Veterinary, Govt. of Arunachal Pradesh carrying PB-3 Rs.15600-39,100/-PM Plus Grade Pay of Rs. 5400/- PM under pay band-3 and other allowances as admissible to Arunachal Pradesh Govt. Employees from time to time. Out of 3 posts, 2 (two) posts are reserved for APST candidate and 1(one) post is unreserved. Vacancy position is subject to variation.

1. Availability of application form and Syllabus:-

Application form alongwith the syllabus are to be downloaded from the Commission's Website [www. appsc. gov. in](http://www.appsc.gov.in).

2. Fee :-

Rs 100/- for APST and 130/- for others in the form of DD/IPO in favour of Secretary, AP PSC, Itanagar.

3. Age :-

A candidate must have attained 18 years of age and should not be more than 30 years as on **24.07.2017**. However, the upper age limit is relaxable by 5 (five) years in case of APST candidates and another 5(five) years for regular Govt. Servant of Arunachal Pradesh.


4. Educational qualification :- A candidate must posses bachelor Degree in Animal Husbandry and Veterinary Science from a recognized University.

However, final year students of Veterinary Science, who are to appear for such final examination shall also be eligible to apply, provided that such candidates are required to submit bonafide certificate testifying their being in final year of the course /last semester Mark sheet issued by the University. Such candidates who are declared to have qualified by the Commission in the Written Competitive Examination will have to produce original Certificate/Mark sheets of their degree examination issued by the Assistant Registrar/Registrar/Controller of Examination/vice chancellor of the concerned university which will only be accepted by the Commission on or before the date of Interview/Viva-voce. Without the original certificate/Mark sheet they shall not be allowed to appear in the Viva-voce.

5. Method of Selection :-

Eligible candidate will have to appear in written examination in the following subjects followed by viva-voce test to be conducted by the Arunachal Pradesh Public Service Commission at Itanagar on the basis of which Selection will be finalized.

(i)	General English & Essay	=	100 marks
(ii)	General Knowledge	=	100 marks
(iii)	Animal Husbandry & Vety. Science (Paper-I)	=	200 marks
(iv)	Animal Husbandry & Vety. Science (Paper-II)	=	200 marks
(v)	Viva-Voce Test	=	<u>75 marks</u>

The number of candidates who shall be called for personality test/viva voce / interview will be in the ratio of 1:3 i.e. 3 candidates for one post as per merit in written examination, subject to securing a minimum of 33% or more marks in each written papers and 45% or more marks in aggregate out of the total marks in the written examinations.

NOTE: The Commission will adopt Recruitment Test (Objective type) before the written examination if it is deemed necessary to do so.

6. How to Apply :-

Along with the duly filled-up format, candidates must enclose the following self-attested documents, otherwise the application will be rejected: -

- (i) **2 (two) copies of recent pass-port size photographs** with self-attestation in the front side of which 1(one) photograph should be pasted on the space provided in the application form and another on the Attendance Sheet.
- (ii) **Self -attested copies** of Degree **Certificates** and **Marksheets** issued by the Assistant Registrar / Registrar / Controller of Examination / Vice Chancellor of the Concerned University as to ascertain Educational Qualification.
- (iii) Final Year Candidate must enclose self-attested **Bonafide Certificate/Marksheet**.
- (iv) Self - attested copy of Matriculation Certificate for proof of age issued by the Board / University only will be accepted.
- (v) **Self-attested copy of Veterinary Council Registration Certificate from India / State Veterinary Council.**
- (vi) Self- Attested copy of APST Certificate for APST candidates and Permanent Resident Certificates (PRC) for Others.
- (vii) Enclose original copy of DD/IPO of Rs 100/- for APST candidates and Rs 130/- for Others.


7. Last date for receipt of application :-

The last date for submission of application form by the Commission is up to **24th July'2017 till 4 PM.**

8. Other Rules:-



- (ii) Candidates already in service may apply direct to this Commission with intimation to his /her Head of Department.
- (iii) Application in the prescribed form should be submitted in the reception counter in a Cover/Envelope super scribed "**Application for the post of Veterinary Officer**" and obtain receipt from the counter to ensure his/her submission of application form.
- (iv) Application form can also be sent "**To the Secretary , Arunachal Pradesh Public Service Commission**" through registered Post/ Courier and should reach the Commission before **4.PM on 24th July'2017.**
- (v) Application form not fulfilling the terms and conditions as stipulated in the advertisement and in application form will be rejected.
