Notification for engagement of Apprentices under Apprentices (Amendment) Act 1973

PUBLIC WORKS DEPARTMENT (PWD), Govt. of Tamil Nadu invites **Online application** from eligible Graduate/Diploma holders in Engineering (**passed during 2015/2016/or 2017**), hailing from Tamilnadu, for undergoing one year Apprenticeship training under the Apprentices (Amendment) Act 1973.

MINIMUM EDUCATIONAL QUALIFICATIONS:

A. Category – I Graduate Apprentices:-

- A Degree in Engineering or Technology granted by a Statutory University in relevant discipline.
- A Degree in Engineering or Technology granted by an Institution empowered to grant such degree by an Act of Parliament in relevant discipline.
- Graduate examination of Professional bodies recognised by the State Government or Central Government as equivalent to above.

B. Category – II Technician (Diploma) Apprentices:-

- A Diploma in Engineering or technology granted by a State Council or Board of Technical Education established by a State Government in relevant discipline.
- A Diploma in Engineering or Technology granted by a University in relevant discipline.
- A Diploma in Engineering and Technology granted by an Institution recognised by the State Government or Central Government as equivalent to above.

III. **AGE:**

Age limit will be followed as per Apprenticeship Rules.

IV. **RESERVATION OF VACANCIES:**

Guidelines under Apprentices Act on Reservation for SC/ST/OBC/PWD will be followed.

V. **MINIMUM PHYSICAL STANDARDS:**

As prescribed in Clause 4 of the Apprenticeship Rule 1992, and amendments thereof if any.

VI. **DURATION OF TRAINING:**

The duration of Apprenticeship training will be for a period of one year as per Apprentices (Amendment) Act 1973.

VII. **PREVIOUS TRAINING/EXPERIENCE:**

Candidates who have already undergone or are currently undergoing apprenticeship under Apprentices (Amendment) Act 1973, and/or having one year or more experience are **not eligible to apply**.

VIII. **SELECTION PROCEDURE:**

Board of Apprenticeship Training (SR) is entrusted with the task of preparation of shortlist from the online application data. Shortlisting of candidates will be done based on the percentage of marks obtained in the basic prescribed qualification as applicable to the respective disciplines. Shortlisted candidates shall be intimated through their registered Email id. Shortlisted candidates have to appear for Certificate Verification at Board of Apprenticeship Training (SR), Chennai.

IX. **TRAVEL EXPENSES:** No TA / DA will be paid for attending certificate verification.

X. **BOARDING/LODGING:** No boarding or lodging expenses are admissible
